Hi Izak,

Thank you for informing us of your upcoming medical/business trip. We have noted that you will be traveling to SOUTH AFRICA from 17/11/2023 to 30/1/2024.

While it seems that you will be engaging in some business activities, the primary purpose of your travel is for medical reasons. If we receive a medical certificate covering the travel period, the allowable Small Business Coaching suspension period would be up to 13 weeks, and the suspension type could be flagged as medical reasons. However, without this, the maximum allowable period for Overseas Travel is 28 days. If we need to place you on a travel suspension, due to the medical nature of the trip, it may be possible for an extension to be provided, although this is not guaranteed.

If the travel is primarily for business purposes, we would be able to continue your Small Business Coaching Agreement during this period but would require the following information by 17/11/23

- L. If the details of your travel were outlined in your Business Plan, please provide the appropriate travel information and documents, including:
 - Business Travel Form (detailing your itinerary and other relevant details)
 - Copy of your airline ticket(s)
 - Proof of business travel insurance.

OR

2. If the details of your travel were not outlined in your Business Plan, you will need to discuss and make appropriate updates to your business plan for approval. Additionally, please supply the above-listed documents and information.

Regardless of the suspension type, an Agreement end date would normally be extended to ensure that you have up to a full 12 months of support.

Please clarify the purpose of the trip ASAP so that we can assess if, and what type of suspension should occur. Please ensure relevant supporting documents are supplied accordingly.
